Dear Sir/Madam.

As you are aware that National Academic Depository (NAD) is an online storehouse of academic awards (Degrees, Diplomas, Certificates, Mark-Sheets, etc.) lodged by the academic institutions/boards/eligibility assessment bodies in a digital format. It is a 24x7 online mode for making available academic awards and shall help in validating their authenticity, their safe storage, and easy retrieval. NAD is comprising two interoperable digital depositories namely NSDL Database Management Limited (NDML) and CDSL Ventures Limited (CVL). These digital depositories shall keep the academic awards in the digital format and ensure data integrity.

The Government of India has designated University Grants Commission (UGC) as an authorised body for implementation of the NAD Project. UGC vide its letter of even no. dated 24th November 2016 requested to all the Academic Institutions viz. Central Universities, Institutions of National Importance, State Universities, Deemed to be Universities, Private Universities, School Boards and Others to enter into a Service Level Agreement (SLA) with either of the depositories for on-boarding on NAD.

I am glad to share with you that till date the NAD has made a very significant progress in last two years and 1,005 Academic Institutions have already signed the SLA and uploading the data on NAD. To enhance the reach of the programme, it is requested that all academic institutions will do the followings and inform UGC accordingly by email on nad.ugc@gmail.com:

- If SLA not signed then you are requested to sign the SLA by 15th June, 2019 and if SLA has been signed then upload the legacy data by 31st July, 2019
- To designate Nodal Officers for implementation of NAD and kindly share the details of Nodal Officers.
- Create a hyperlink of National Academic Depository (NAD) URL I.e. http://www.nad.gov.in in their respective website.
- Add a compulsory field/column of named "NAD" in both online and offline Admission /Examination form.
- University shall provide a unique ID to students which will be the NAD ID of student so that awards can be mapped with students' account.
- Create awareness about NAD among the students through notices, events, lectures, etc., emphasizing
 how they can avail the facilities like access, verification, and authentication of its own awards in a
 digital format.
- Provide University/College wise total enrolment of students from 2017-18 on above-mentioned email.

To attain the objectives of NAD, you are requested to kindly upload the legacy and fresh data of your institution before 30th September, 2019.
